- Participate in Regional Conference calls (minimum 2 x per month)
- Participate in Regional Board list serve (checking and responding to email regularly)
- Accept invitations to speak at MI Region Induction and other $\Phi\Theta\text{K}$ events
- Make every effort to attend the 2019 Convention (April 4-6, in Orlando, FL)

During the time I hold office, I agree to be registered at _____ College, taking at least **three credit hours** of community college level work **each semester** and be engaged with my Phi Theta Kappa Chapter. I further certify that I am currently a member in good standing of my chapter. I also certify that I have reliable means of transportation to attend the meetings I'm obligated to attend. I realize that if I fail to fulfill these conditions, I may forfeit my office.

I understand that I will receive a stipend of up to \$400 (contingent on a vote of the Region) for my expenses as an officer, that my room, registration and some meals at each official Regional meeting will be paid for, and that I will receive registration, shared hotel and travel expenses (contingent on a vote of the Region) to attend the 2019 Annual Convention.
